## Sub: Postponement of the applicability of revised Stamp duty rate

To our esteemed clients,

This is with reference to our earlier circular no. <u>ASPL/Cir/19-20/004</u> dated January 08, 2020 and circular no. <u>ASPL/Cir/19-20/005</u> dated January 09, 2020 informing you about the revision of stamp duty rate which was supposed to be effected from January 09, 2020 which later got postponed to April 01, 2020. The Ministry of Finance (Department of Revenue) vide their notification dated March 30, 2020 had further postponed the date of implementation of the revised stamp duty rate to **July 01, 2020**.

In accordance with the above, the revised rate of stamp duty shall be effective from the trade date 1<sup>st</sup> July 2020. The revised stamp duty shall be levied at the following rate depending on the type of transactions done by the client:
